



PREAMBLE

O Allah! The Creator of the heavens and the earth, the Knower of the Unseen and the Seen, the Compassionate the Merciful, I make this covenant with You that;

I bear witness that there is no deity but Allah, the One, the Merciful, the Almighty –Creator of the heavens and the earth and all therein–God of Abraham, Moses, Jesus, Muhammad, and all the Prophets, mercy and peace be upon them all. He is One God and He has no partner. And I bear witness that the Prophet Muhammad is His servant and His Messenger and the last of all the Prophets, mercy and peace be upon him and his pure progeny, and he is Your Devotee and Messenger and that the Day of Judgment will be coming without doubt, and that You will raise whoever is in the grave and that Heaven and all what is promised in it is real, and that Hell is real, and Faith is right and Religion is right as You have described it, and that Islam is what you ordained, and that the Quran is as You revealed, and that You are Allah the Truth, the Manifest. I make this covenant in this world that I am pleased with You as my Lord, and with Islam as my religion and the Prophet Mohammad is your trustworthy messenger, and the holy Quran as my Scripture and Ali as Wali-ullah, , and Hassan and Husain the sons of Ali, and Ali son of Husain, and Mohammad al-Baqir son of Ali, and Ja'far al-Sadiq son of Muhammad, and Musa al-Kadem son of Ja'far, and Ali al-Reda son of Musa, and Muhammad al-Jawaad son of Ali, and Ali al-Hadi son of Muhammad, and Hassan al-Askari son of Ali and Mahdi; the Awaited one are my Imams.

This is my counsel to my relatives and friends, my Muslim brothers and sisters, and all those who remain after me, that they strive to be true servants of Allah, that they surrender to their Creator-may He be exalted- and worship Him as He alone deserves worshiping, fear disobeying Him as He alone is to be feared, And to love Him and His Prophet Muhammad and the appointed twelve Imams with a complete that is rivaled by nothing besides them. Let them obey Him and hold fast to His shari'ah. Let them die only in a state of complete submission to His Will.

I remind them that no man/woman dies before his/her time. The exact duration of each life span is precisely determined before we are born, by the all powerful Creator, may He be exalted. Death is tragic only for the one who lived out his/her life in self-deception without submitting to the Creator and preparing for the final return to Him. So, do not preoccupy yourself with my death, but instead, make the proper preparations for your own.

Maintain patience and self-composure as the religion of Islam requires from you. When you remember me do not wail excessively or weep for me but remember me when you pray, when you recite the holy Quran, when you are giving charity, and when you are asking for forgiveness from Allah, pray that Allah joins us in paradise.

Finally, I ask all my relatives, friends, and all others, whether they choose to believe as I believed or notto honor my Constitutional rights to these beliefs. I ask them to honor this document which I have made, and not to try to obstruct it or change it in any way. Rather, let them see that I am buried as I have asked to be buried and let my properties be divided as I wanted them to be divided.




ARTICLE V: DISTRIBUTION OF REMAINDER OF MY ESTATE

I direct, devise, and bequeath all the residue and remainder of my estate after making provision for payment of my obligations and distributions provided in Article III and Article IV, only to my Muslim heirs whose relation to me, whether ascending or descending, has occurred through Islamic or lawful marriage at each and every point. The distribution of the residue and remainder of my estate shall be made strictly in accordance with:

MAWARITH (Inheritance) (THE ISLAMIC DISTRIBUTION OF THE ESTATE)

- 1. Should I die as a result of murder, I direct that the adjured murderer, principal or accessory in the murder, shall be disqualified to receive any part of my estate.
- 2. I direct and devise that any fetus, conceived before death, whose relationship to me qualifies it to be an heir according to this Article, shall be considered as an heir if the following condition is fulfilled: the fetus should be born alive within 365 days of my death. I further direct and devise that, whenever there exists a fetus who may become an heir according to this section, the whole distribution of the residue and remainder of my estate after the execution of Articles III and IV, shall be delayed until after the birth of the fetus.
- 3. I direct, devise, and bequeath all the residue and remainder of my estate of every nature and kind and wherever situated after making provisions for payments of my obligations and distribution of my estate as provided in Articles III and IV.





ARTICLE VI: SEPARABILITY

I direct and declare that if any part of this Last Will and Testament is determined invalid by a court of competent jurisdiction, the other parts shall remain valid and enforceable. This LAST WILL AND TESTAMENT comprising of eight pages is made in **ONE ORIGINAL** only. Five copies of this original are made.
